### **The organizing authority:**

Kerteminde Sejlklub has the pleasure to invite you to the Gold Cup 2007 for Nordic Folkboats

### **1. Time and Place.**

The Gold Cup will take place in the period from Wednesday 15th to Saturday 18th of August 2007 in Kerteminde, Denmark.

The official opening of the Gold Cup will be Wednesday 15th August at 19.00 hours.

### **2. Rules.**

2.1 The NFIA Statutes for the Gold Cup, revision 2001 will apply.

2.2. The regatta will be governed by the 'rules' as defined in the Racing Rules of Sailing RRS 2005-08.

2.3 The Sailing Instructions with the applying Danish/Scandinavian national prescriptions incorporated will be available at registration.

2.4 RRS are changed as follows:

- Rules 44.1 and 44.2 are changed to 1 round.
- Rule 35 and A4 are changed: Boats not finishing within 60 minutes after finish of the first boat will be scored DNF.
- Preamble to part 4 is changed for personal buoyancy not limited to boats racing.
- Rule A4 are changed as follows: Boats starting later than 4 minutes after the start signal, will be scored DNS.
- Rule 60.1(a) is changed to: Prevent boats to protest against parts of the SI.
- Rule 61.3 and 62.2 are changed so protest time limits are applicable for both protests and requests for redress from boats and protests from RC (Regatta Committee) and PC (Protest Committee).
- Rule 66 are changed so time limit for reopening is changed.

The exact wording of the changes will be clarified in the Sailing Instructions.

2.5 If there are any conflict between language, the english text will take precedence.

### **3. Eligibility and Entry.**

3.1. The Gold Cup is open to Nordic Folkboats from all nations in accordance with the NFIA Gold Cup statutes, which states the requirements of memberships for helmsman and crew.

3.2. Only Folkboats with a valid measurement certificate and a valid third party insurance certificate can compete.

3.3. Each yacht's formal entry shall be submitted on the enclosed entry form or from [www.kerteminde-sejlklub.dk](http://www.kerteminde-sejlklub.dk) and shall be accompanied by

- A copy of the yacht's valid measurement certificate.
- A copy of the yacht's valid third party insurance certificate.
- An entry fee of Euro 125 / Dkr. 950.
- Documentation for the helmsman and the crew's membership of a yacht club recognised by ISAF.
- Documentation of NIFA membership for the helmsman.
- Pawn ticket, if you are sailing in a borrowed boat.

**3.4.** Entry forms shall be delivered to Kerteminde Sejlklub no later than Wednesday the 1st of August 2007. The entry fee is due to payment when the entry has been confirmed. The entry is binding. Entry after deadline can be accepted, after a valuation of the race committee and an administrative fee of euro: 10 / Dkr. 75.

#### **4. Registration.**

**4.1.** Yachts must register at the Regatta Office located in the club house. Registration must be fulfilled before Wednesday 15th of August 2007 at 19.00 hours.

**4.2.** At registration or before the participating boats must fill in attached sail registration form for sails used in the regatta.

**4.3.** Yachts not complying with 4.1. will be scored as DNC, and the entry fee will not be refunded, except with and according to the terms of prior written permission of the race committee.

#### **5. Schedule.**

**5.1.** The Warning signal for the first race Thursday 16th August will be at 09.55

**5.2.** There are scheduled 2 races Thursday, Friday and Saturday.

**5.3.** If a race cannot be completed on the day it is planned, an attempt will be made to complete the race the following day.

#### **6. Measurement.**

**6.1.** Measurement of yachts and sails takes place during the regatta. The Folkboats chosen for the random check will be informed at the bulletin board.

**6.2.** According to NFIA rule 19.7 all sails to be applied shall carry a red NFIA sail button. No more than 2 suits of sails are allowed. Button numbers will be requested at registration.

#### **7. Courses.**

The courses will be a modified up/down course.  
A map of the racing area will be handed out with the SI.

#### **8. Score.**

6 races are planned. 4 races must be completed to award the Gold Cup.

When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.

When 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

#### **9. Prizes.**

**9.1.** The Gold Cup for Nordic Folkboats, the prize of senator Hagelstein will be awarded to the winner according to the Gold Cup Statutes.

**9.2.** In addition there are prizes for every fifth starting boat. However no more than a total of 10 prizes will be awarded.

## **10. Safety.**

Every boat shall be equipped with personal buoyancy for the number of persons on board at any time.

## **11. Haul-Out Restrictions.**

Boats shall not be hauled out during the regatta from 08.00 hrs. on the first racing day until the last boat finishes the last race, except with and according to the terms of prior written permission of the race committee.

## **12. Diving and Plastic Equipment.**

Underwater breathing apparatus and plastic pools or their equivalent shall not be used around the boats from 08.00 hrs. on the first racing day until the last boat finishes the last race.

## **13. Radio Communication.**

A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

## **14. Disclaimer of Liability.**

Competitors participate in the regatta entirely at their own risk. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## **15. Insurance.**

Each participating boat shall be insured with valid third-party liability insurance.

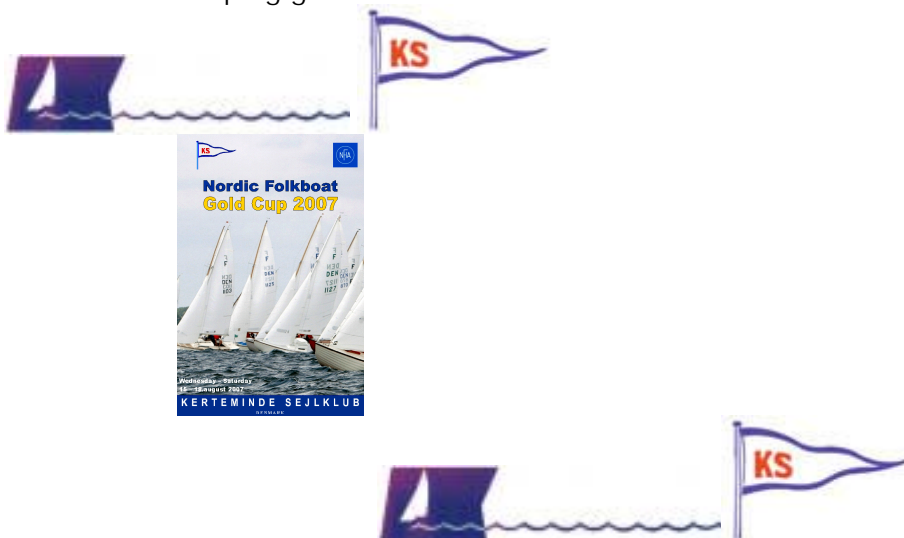
